

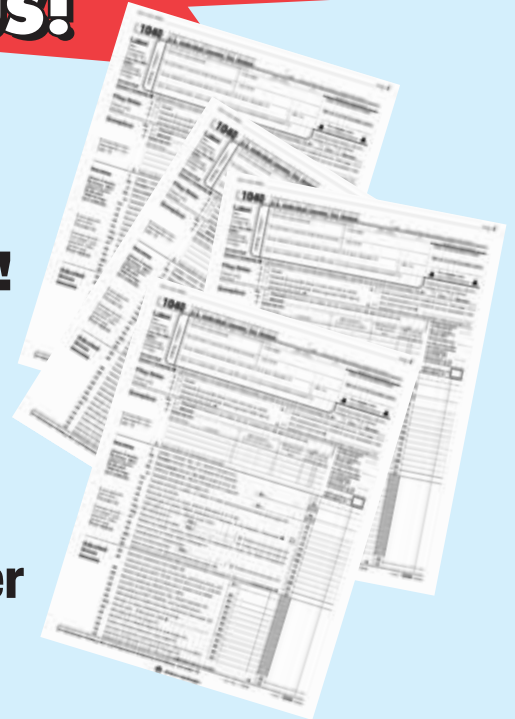

Lower rates may be available. Our offer is further conditioned on your continuing to meet the criteria used to prescreen this offer, and on other specific criteria bearing on credit worthiness, which include the following: Your monthly vehicle payment can not exceed 18% of your gross monthly income.
